Dr Newhouse gave a statement about the NHS and in particular the 44 Sustainability Transformation Plans which will cause massive changes in the NHS. There is a facebook page "Support the NHS Halstead" which gives details. The major change locally is the amalgamation of Colchester and Ipswich hospitals and the fact that the Braintree hospital is to become an orthopaedic only hospital. She raised concerns over the lack of services in the community to help people who leave hospital early.
